



**SECOND AMENDMENT TO THE AGREEMENT
BETWEEN OKALOOSA COUNTY, FLORIDA
AND THE HILLER COMPANIES, LLC
CONTRACT NO. C23-3366-FM**

This Second Amendment to the Agreement between Okaloosa County, a political subdivision of the State of Florida (the "County"), and The Hiller Companies, LLC (the "Contractor"), executed this 16th day of January, 2024, is made a part of the original Agreement dated July 20, 2023, Contract No. C23-3366-FM (the "original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

1. **AMENDED PROVISION.** The County and the Contractor wish to amend Section 4 of the original Agreement to include language below regarding minor repairs found during routine inspections and to add an additional location.

The Contractor may repair issues at the time of inspection if the costs of such repair is under \$250.00. Anything over that amount will require an approval of a written quote.

- CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.

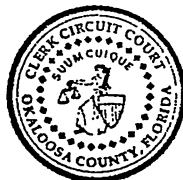
