

FIRST AMENDMENT TO THE AGREEMENT BETWEEN

This First Amendment to the Agreement between Santa Rosa County a political subdivision of the state of Florida (the "County"), and Edwards Roofing Company, Inc., executed this 26th day of May, 2022, is made a part of the original Agreement dated June 8, 2021 The "original Agreement", incorporated herein by reference. The County and Contractor hereby agree as follows:

1. **OPTION TO RENEW.** The parties hereby wish to exercise their First option to renew the original Agreement for an additional One (1) year term in accordance with Section 3 of the original Agreement.
2. **EFFECTIVE DATE OF RENEWAL TERM.** The Effective Date of this Amendment shall commence June 8, 2022 and shall terminate no later than June 7, 2023.
3. **COMPENSATION.** Compensation for this renewal term of the Agreement shall:

Stay the same as set forth in Section 4 of the original Agreement ("Compensation") and/or any amendments thereto;
4. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated June 8, 2021 and any amendments thereto, shall remain in full force and effect.
5. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.

ACTION NEEDED

Discussion and approval to renew a contract with Edwards Roofing Company, Inc. and a contract with Porter Roofing Contractors, Inc. as the two revolving roofing contractors for county-maintained facilities.

SUMMARY/BACKGROUND

Contracting this service is necessary to repair or replace roofs on county facilities. As of April 22, 2022, the following task orders have been issued to the two roofing companies.

- Edwards Roofing- 17 task orders for \$261,054
- Porter Roofing- 8 task order for \$86,998

RECOMMENDATION

Recommend approval to execute this agreement.

FISCAL IMPACTS

Funds are available for these services in account 546001 - Repair and Maintenance. This contract will also be acceptable for services related to federally-funded reimbursements.
