MODIFICATION #10 TO CONTRACT NUMBER E194-75647 BETWEEN THE COMMONWEALTH OF VIRGINIA AND ABACUS CORPORATION

This MODIFICATION #10 is an Agreement between the Commonwealth of Virginia, hereinafter referred to as "State" or "Commonwealth," and ABACUS CORPORATION hereinafter referred to as the "Contractor" or "Abacus", relating to the renewal modification of Contract E194-75647 effective July 1, 2017, as amended, hereinafter referred to as the "Contract" or "Agreement." This Modification is hereby incorporated into and made an integral part of the Agreement.

The purpose of this modification is to document both parties' agreement to extend this contract for three (3) additional months. This extension will be effective from July 1, 2022 through September 30, 2022.

The following modifications will apply to this Contract Modification:

Contract E194-75647 currently expires on July 1, 2022 and is being extended through September 30, 2022. Beginning October 1, 2022 and ending December 31, 2022, there will be a three (3) month transition period. This transition period will not allow for any new purchase orders to be processed. All purchase orders issued "under" Contract E194-75647 must be closed by September 30, 2022.

The foregoing is the complete and final expression of the parties' agreement to modify Contract E194-75647 and cannot be modified, except by a writing signed by the duly authorized representatives of both parties. All other terms and conditions remain unchanged.
