I. Purpose

Halff Associates, Inc. (CONSULTANT) shall provide Okaloosa County (COUNTY) with engineering services necessary to support the development of design drawings for conduit installation for approximately 3.9 miles along Straight Line Rd and Colonel Greg Mallory Rd from Okaloosa Youth Academy to SR 85. The project is located primarily within Okaloosa County Right of Way. However, the project will terminate within the FDOT Right of Way of SR 85. As such, FDOT utility permit will be necessary at the intersection of Colonel Greg Mallory Rd and SR 85.

II. Scope of Services

The following services are anticipated for the completion of this project:

A. Coordination of Utilities

CONSULTANT will provide limited Utility coordination at the intersection of Colonel Greg Mallory Rd and SR 85. Consultant will submit a design locate ticket through Sunshine 811 and coordinate with existing utility owners to include the locations of responsive existing utilities for the purposes of submitting a FDOT utility permit. Coordination will also include notifying existing utility owners of the proposed work as required by the FDOT permitting process.

B. Develop Permit Plans and submit plans for a FDOT Utility Permit

CONSULTANT will produce a 100-scale pdf design drawing of the COUNTY's desired conduit installation and aerial imagery for reference for 3.9 miles along Straight Line Rd and Colonel Greg Mallory Rd from Okaloosa Youth Academy to SR 85.

Existing utility information will only be shown at the intersection of Colonel Greg Mallory Rd and SR 85 as required for the purposes of an FDOT utility permit. The utility information obtained from utility owners will be placed in the intersection plansheet and labeled for approximate horizontal distances as required by the FDOT permitting process. CONSULTANT will submit the FDOT utility permit for the conduit work at the intersection of SR 85 and Colonel Greg Mallory Rd on behalf of the COUNTY.

III. COUNTY Responsibilities

- A. Provide CONSULTANT with Right of Way shapefile for use in the plans.
- B. Payment of any and all impact, review and permitting fees.
- C. Provide CONSULTANT with any information, agreements, and/or restrictions that may be in effect on the property and impact the design guidelines or criteria for the project.
- D. The COUNTY shall provide CONSULTANT with access to the site for activities necessary for the performance of the services.

IV. Excluded Services

CONSULTANT'S Scope of Services expressly does not include the following services which are the obligation of the COUNTY or Owner, as the case may be.

- A. Environmental/Biological Services and Permitting
- B. Geotechnical, Architectural, Structural, Foundation Design, Mechanical, or Electrical Services
- C. Survey
- D. Fiber Optic Splice Diagrams
- E. Building conduit entry details
- F. Existing utility information beyond the intersection of SR 85 and Colonel Greg Mallory Rd.
