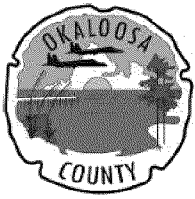

STATEMENT OF ISSUE: Request approval of the renewal to the Zoll Medical Corporation cardiac monitor lease extending the agreement one (1) additional year at an annual cost of \$134,640.

BACKGROUND: Okaloosa County entered into a 3-year agreement with Zoll Medical Corporation on March 3, 2020, to lease cardiac monitors. The current lease agreement expires on March 2, 2024; however, the lease agreement allows for two (2) additional 1-year renewals. The renewal will extend the lease agreement until March 2, 2025, at a cost of \$134,640 annually. These funds are budgeted as part of the EMS annual budget.
