AGREEMENT NO. 20-148-ITB**

**AMENDMENT NUMBER 1
ASSIGNMENT OF AGREEMENT**

This Amendment Number 1 ("Amendment") is made on the date of execution by the County and amends Agreement Number 20-148-ITB ("Main Agreement") between Western Branch Diesel, LLC, 12011 Balls Ford Road, Manassas, VA 20109 ("Contractor"), and the County Board of Arlington County, Virginia ("County").

Western Branch Diesel, LLC and the County entered into the Main Agreement for Western Branch Diesel, LLC to provide Detroit Diesel Engine and Allison Transmission Original Equipment Manufacturer (OEM) parts and repairs/warranty services on an as-needed basis, for up to five (5) years.

Johnson Truck Center, LLC has assumed all of Western Branch Diesel, LLC rights and obligations in the Main Agreement. The work and payment called for under this amendment shall be subject to all terms and conditions of the Main Agreement unless specifically changed by the terms and conditions of an additional amendment.

The County consents to the assignment of the Main Agreement to Johnson Truck Center, LLC retroactively effective on July 1, 2021 ("Effective Date").

The Main Agreement is therefore amended as follows:

1. Western Branch Diesel, LLC is in all instances replaced with Johnson Truck Center, LLC;
2. The term "Contractor" in the Main Agreement means Johnson Truck Center, LLC;
3. The Notices for Johnson Truck Center, LLC shall be delivered to:

4. The second renewal term is hereby exercised for the contract term of July 1, 2021 through June 30, 2022.

All other terms and conditions of the Main Agreement remain in full force and effect.
