**AMENDMENT NUMBER 17-298-ITB-LW
ASSIGNMENT OF AGREEMENT**

This Amendment Number 1 ("Amendment") is made on the date of execution by the County and amends Agreement Number 17-298-ITB-LW ("Main Agreement") between GrassHoppers Lawncare & Repair, 18649 Old Valley Pike, Edenburg, Virginia 22824 ("Contractor"), and the County Board of Arlington County, Virginia ("County").

GrassHoppers Lawncare & Repair and the County entered into the Main Agreement for GrassHoppers Lawncare & Repair to provide mowing and refuse collection services.

Blue Mountain Mowing Co., LLC has assumed all of GrassHoppers Lawncare & Repair rights and obligations in the Main Agreement. The work and payment called for under this amendment shall be subject to all terms and conditions of the Main Agreement unless specifically changed by the terms and conditions of an additional amendment.

The County consents to the assignment of the Main Agreement to Blue Mountain Mowing Co., LLC beginning on 1/3/2023 ("Effective Date").

The Main Agreement is therefore amended as follows:

1. GrassHoppers Lawncare & Repair is in all instances replaced with Blue Mountain Mowing Co., LLC;
2. The term "Contractor" in the Main Agreement means Blue Mountain Mowing Co., LLC;
