AGREEMENT NO. 17-181-R AMENDMENT NUMBER 5

This Amendment Number 5 is made on the date of execution by the County and amends Agreement Number 17-181-R ("Main Agreement") dated 10/1/2017 between JDL Ventures, dba Jeffrey's Catering Co. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

ADD THE FOLLOWING LANGUAGE AS PARAGRAPH 20. COVID-19 VACCINATION POLICY FOR CONTRACTORS:

Due to the ongoing COVID-19 pandemic, the County has taken various steps to protect the welfare, health, safety, and comfort of the workforce and public at large. As part of these steps, the County has implemented various requirements with respect to health and safety including policies with respect to social distancing, the use of face-coverings and vaccine mandates. To protect the County's workforce and the public at large, all employees and subcontractors of the Contractor who are assigned to this Contract, should be fully vaccinated against COVID-19. Any contractor employee or subcontractor who is not fully vaccinated should be following a weekly testing protocol as established by the Contractor, unless exempt pursuant to a valid reasonable accommodation under state or federal law.

REPLACE PARAGRAPH 1. CONTRACT DOCUMENTS IN ITS ENTIRETY AND REPLACE IT WITH THE FOLLOWING LANGUAGE:

The Contract Documents consist of this Agreement, Exhibit A Fairfax County Agreement #4400007686, Exhibit B Non-Disclosure & Data Security Agreement, Exhibit C Location List together with any exhibits and amendments issued or applicable thereto (collectively, "Contract Documents" or "Contract"). This Agreement rides a contract awarded to the Contractor by Fairfax County and extended by the Contractor to the County on the same terms and conditions as the Contractor's agreement with Fairfax County. Where the terms of this Agreement vary from the terms and conditions of the other Contract Documents, the terms and conditions of this Agreement shall prevail.

The Contract Documents set forth the entire agreement between the County and the Contractor. The County and the Contractor agree that no representative or agent of either of them has made any representation or promise with respect to the parties' agreement which is not contained in the Contract Documents.
