**AGREEMENT NO. 20-850-SS
AMENDMENT NUMBER 2**

This Amendment Number 2 is made on the date of execution by the County and amends Agreement Number 20-850-SS (“Main Agreement”) dated July 22, 2020 between Reigning Champs Football LLC (“Contractor”) and the County Board of Arlington County, Virginia (“County”).

The County and the Contractor agree to amend the Main Agreement as follows:

1. ADD SECTION #34. COVID-19 VACCINATION POLICY FOR THE CONTRACTORS TO THE CONTRACT AS FOLLOWS:

34. COVID-19 VACCINATION POLICY FOR CONTRACTORS:

Due to the ongoing COVID-19 pandemic, the County has taken various steps to protect the welfare, health, safety, and comfort of the workforce and public at large. As part of these steps, the County has implemented various requirements with respect to health and safety including policies with respect to social distancing, the use of face-coverings and vaccine mandates. To protect the County’s workforce and the public at large, all employees and subcontractors of the Contractor who are assigned to this Contract, should be fully vaccinated against COVID-19. Any contractor employee or subcontractor who is not fully vaccinated should follow a weekly testing protocol as established by the Contractor, unless exempt pursuant to a valid reasonable accommodation under state or federal law. By submitting a proposal, the Offeror certifies that it will comply with this provision and will ensure that its subcontractors, if any, do so as well.

2. PURSUANT TO PROVISION 4: CONTRACT TERM, THIS AGREEMENT IS HEREBY RENEWED FROM JULY 22, 2022 TO JULY 21, 2023.

All other terms and conditions of the Main Agreement remain in effect.



EXHIBIT A

SCOPE OF WORK AND PRICING

Arlington NFL Youth Flag Football is part of the National Football League's official flag football program ("NFL FLAG"), the only NFL-affiliated youth program with NFL team-branded jerseys and equipment (e.g. appropriately sized footballs for youth participants).

Reigning Champs Football LLC operates the NFL FLAG program under license from the National Football League and its subsidiaries and affiliates. The NFL team names, logos, indicia and uniform designs are trademarks of the NFL teams indicated. All other NFL-related trademarks (including but not limited to the NFL FLAG powered By Reigning Champs logo and the NFL Shield design) are trademarks of the National Football League. Reigning Champs Football LLC shall provide the Official NFL Team Gear equipment package, including one NFL team-reversible jersey and one official NFL FLAG belt, for each player and one football for every five players.

The equipment package fee is \$25 per player. The estimated quantity is 1,600 players, but the County may adjust this quantity at its sole discretion.
