AMENDMENT NUMBER 1

This Amendment Number 1 ("Amendment") is made on the date of execution by the County and amends Arlington County Agreement Number 516-15, dated November 3, 2015 ("Main Agreement") and made between Rice Associates, Inc., 10661 Gaskins Way, Manassas, VA 20109 ("Contractor"), a Virginia Corporation authorized to transact business in the Commonwealth of Virginia, and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Contract Term of the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows:

I. Amend Paragraph 3 ("Contract Term"), Pages 1-2 of the Main Agreement to read as follows:

**3. CONTRACT TERM**

The Work shall commence upon execution of this Agreement by the County and shall continue until October 31, 2018 ("Second Subsequent Contract Term"), subject to any modifications as provided for in the Contract Documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may, through issuance of an amendment executed by the parties, authorize continued operations of the Contractor for not more than two (2) additional twelve (12) month periods from November 1, 2018 until October 31, 2020 (each such period shall be referred to as a "Subsequent Contract Term").

All other terms and conditions of the Main Agreement, as amended, shall remain in full force and effect.
