

AMENDMENT NUMBER 1

This Amendment Number 1 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement Number 18-073-ITB-LW, dated January 23, 2018 ("Main Agreement") made between The Davey Tree Expert Company, 10301 Richmond Hwy, Lorton, VA 22079 ("Contractor") and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Pricing Schedule called for under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this amendment, amend the Main Agreement as follows:

- I. Revise the Pricing Schedule to include the following:

Installation, Removal and Filling of Tree Gator Water Bags

Provision and installation of a 20-gallon Tree Gator Water Bag during the growing season and removal of bag in November of each year. All Tree Gator Water Bags collected at the end of the growing season shall be stored at the Contractor's facility for future use. This service shall be required for up to a two-year period per tree. Costs shall be as follows:

Initial Installation and Removal: \$60.00 ea

2<sup>nd</sup> Year Installation and Removal with Tree Gator Bags stored from previous year: \$30.00 ea

Filling of Tree Water Gator Bags:

Fill a 20-gallon Tree Gator Water Bag with potable water: \$18.00 per bag per watering

One-year watering per bag: \$270.00

All other terms and conditions of the Main Agreement, as amended shall remain in full force and effect.
