FIRST AMENDMENT TO THE AGREEMENT BETWEEN OKALOOSA COUNTY, FLORIDA AND SUMMIT FOOD SERVICE, LLC CONTRACT NO. C23-3388-COR

This First Amendment to the Agreement between Okaloosa County, a political subdivision of the State of Florida (the "County"), and Summit Food Service, LLC (the "Contractor") executed this day of <u>September</u>, 2023, is made a part of the original Agreement dated October 1, 2023, Contract No. C23-3388-COR (the "original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

- 1. **AMENDED**. The previous inmate food service provider abandoned their contractual duties and therefore, the County and Contractor wish to amend Section 3 of the original Agreement to allow for an emergency start of their contract duties. The Contractor will begin work as detailed in the scope of the original Agreement on September 27, 2023.
- 2. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated October 1, 2023 and any amendments thereto, shall remain in full force and effect.
- 3. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.
