WHEREAS, project construction has been awarded and is anticipated to be complete by Summer 2024; and


WHEREAS, both parties agree this is the final extension and any funds not submitted for reimbursement by September 30, 2024 will be forfeited.



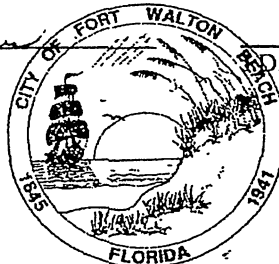

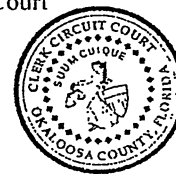
