ARLINGTON COUNTY, VIRGINIA AGREEMENT NO. 17-084-RFP-2 AMENDMENT NUMBER 2

This Amendment Number 2 is made on August 1, 2022, and amends Agreement Number 17-084-RFP-2 ("Main Agreement") dated September 4, 2018, between Rinker Design Associates, P. C. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Contract Terms and Conditions called for under the Main Agreement as follows:

- 1. Contract Renewal: Pursuant to Section 4. Contract Term, the contract is hereby renewed for its third subsequent contract term for an additional 12-month period from August 1, 2022 to July 31, 2023 with one additional 12-month renewal remaining.
- 2. <u>Force Majeure</u> is hereby amended as follows:

29. FORCE MAJEURE

Neither party will be held responsible for failure to perform the duties and responsibilities imposed by this Contract if such failure is due to a fire, riot, rebellion, natural disaster, war, act of terrorism or act of God that is beyond the control of the party and that makes performance impossible or illegal, unless otherwise specified in the Contract, provided that the affected party gives notice to the other party as soon as practicable after the force majeure event, including reasonable detail and the expected duration of the event's effect on the party.

3. <u>COVID-19 Vaccination Policy For Contractors</u> is hereby incorporated into the Contract Terms and Conditions as follows:

55. COVID-19 VACCINATION POLICY FOR CONTRACTORS

Due to the ongoing COVID-19 pandemic, the County has taken various steps to protect the welfare, health, safety, and comfort of the workforce and public at large. As part of these steps, the County has implemented various requirements with respect to health and safety including policies with respect to social distancing, the use of face-coverings and vaccine mandates. To protect the County's workforce and the public at large, all employees and subcontractors of the Contractor who are assigned to this Contract, should be fully vaccinated against COVID-19. Any contractor employee or subcontractor who is not fully vaccinated should be following a weekly testing protocol as established by the Contractor, unless exempt pursuant to a valid reasonable accommodation under state or federal law.

All other terms and conditions of the Main Agreement remain in effect.
