**AGREEMENT NO. 21-DMF-ITB-262-GC-1  
AMENDMENT NUMBER 1**

This **Amendment Number 1** is made on **October 15, 2021** by the County and amends Agreement Number 21-DMF-ITB-262-GC-1 ("Main Agreement") dated November 10, 2020 between **Centennial Contractors Enterprises, Inc.** ("Contractor") and the **County Board of Arlington County, Virginia** ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

1. PURSUANT TO PRVISION 4: **CONTRACT TERM**, THE COUNTY HEREBY EXERCISES THE 1<sup>ST</sup> OF TWO (2) ONE YEAR OPTION EXTENSIONS FOR THE PERIOD OF NOVEMBER 10, 2021 TO NOVEMBER 9, 2022.
2. ADD PROVISION 55: **COVID-19 VACCINATION POLICY FOR CONTRACTORS**, which is incorporated into and made part of this Amendment as follows:

**55. COVID-19 VACCINATION POLICY FOR CONTRACTORS**

Due to the COVID-19 pandemic, the County has taken various steps to protect the welfare, health, safety and comfort of the workforce and public at large. As part of these steps, the County has implemented various requirements with respect to health and safety including policies with respect to social distancing, the use of face-coverings and vaccine mandates. All County Contractors, entering County owned, controlled, or leased facilities or facilities operated by a contractor if the services provided at that location are exclusive to Arlington County Government or contractors with public facing responsibilities must adopt these policies for implementation with their employees and subcontractors working on County contracts.

Contractors are required to obtain and maintain the COVID-19 vaccine status of employees or subcontractors, require any unvaccinated or not fully vaccinated employees to follow a weekly testing protocol established by the Contractor to submit to weekly testing, and provide any accommodations as required by law. Contractor should submit the certification of compliance to the Purchasing Agent at the time of contract execution and within five working days of the end of each quarter (see Exhibits E). In addition, all Contractor and subcontractor employees subject to the requirements of this section must also comply with the County COVID-19 masking and social distancing protocols, as signed at each County location.

All other terms and conditions of the Main Agreement remain in effect.
