AMENDMENT NUMBER <u>5</u> ASSIGNMENT OF AGREEMENT

This Amendment Number 5 ("Amendment") is made on	9/30/2021 and amends Agreement
Number 19-016-RFP-31 ("Main Agreement") between Silv	er Knights Enrichment, LLC, 4031 University
Drive, Suite 100, Fairfax, Virginia 22030 ("Contractor"), and t	the County Board of Arlington County, Virginia
("County").	

Silver Knights Enrichment, LLC and the County entered into the Main Agreement for the provision of summer camp services for DPR to provide <u>summer camps for chess and STEM (coding and robotics)</u>.

Silver Knights Chess, LLC has assumed all of Silver Knights Enrichment, LLC rights and obligations to provide <u>summer camps for chess</u> in the Main Agreement. The work and payment called for under this amendment shall be subject to all terms and conditions of the Main Agreement unless specifically changed by the terms and conditions of an additional amendment.

The County consents to the assignment of <u>summer camps for chess</u> of the Main Agreement to Silver Knights Chess, LLC beginning on <u>August 30, 2021</u> ("Effective Date"). Silver Knights Chess, LLC and the County Board of Arlington County, Virginia will enter into Agreement No. 19-016-RFP-37 for the provision of summer camp services for DPR to provide <u>summer camps for chess</u>.

The Main Agreement is therefore amended as follows:

- 1. Silver Knights Enrichment, LLC is in all instances replaced with Silver Knights Chess, LLC in reference to providing summer camp for chess only;
- 2. The term "Contractor" in the Main Agreement for <u>summer camps for chess only</u> means Silver Knights Chess, LLC;
- 3. **Contract Renewal:** The Contract term for summer camps for STEM (coding and robotics) is hereby renewed for its third subsequent contract term period beginning September 15, 2021, through September 14, 2022.
- 4. **Contract Documents:** The following Contract Documents are hereby **added**:
 - Exhibit E COVID-19 Vaccination Policy for Contractors Certification Form (attached) Exhibit F Contractor COVID-19 Vaccination Quarterly Compliance Certification (attached)
- **5. Incorporation of COVID-19 Vaccination Policy for Contractors:** Clause Number 54. COVID-19 Vaccination Policy for Contractors is hereby added to the Contract Terms and Conditions.

COVID-19 VACCINATION POLICY FOR CONTRACTORS

Due to the COVID-19 pandemic, the County has taken various steps to protect the welfare, health, safety and comfort of the workforce and public at large. As part of these steps, the County has implemented various requirements with respect to health and safety including policies with

respect to social distancing, the use of face-coverings and vaccine mandates. All County Contractors, entering County owned, controlled, or leased facilities or facilities operated by a contractor if the services provided at that location are exclusive to Arlington County Government or contractors with public facing responsibilities must adopt these policies for implementation with their employees and subcontractors working on County contracts.

Contractors are required to obtain and maintain the COVID-19 vaccine status of employees or subcontractors, require any unvaccinated or not fully vaccinated employees to follow a weekly testing protocol established by the Contractor to submit to weekly testing, and provide any accommodations as required by law. Contractor should submit the certification of compliance to the Purchasing Agent at the time of contract execution and within five working days of the end of each quarter (see Exhibits F). In addition, all Contractor and subcontractor employees subject to the requirements of this section must also comply with the County COVID-19 masking and social distancing protocols, as signed at each County location.

It is recognized that the COVID-19 pandemic is an ongoing health crisis. As such, requirements with respect to health and safety, including vaccines and face-coverings may change over time. Contractors are expected to adhere to the County requirements as they evolve in response to the crisis.
