The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:


1. AMEND THE CONTRACT TERM AS FOLLOWS:

The Contract Term shall be extended for period of twelve (12) months, commencing July 1, 2020 and concluding June 30, 2021.


All other terms and conditions of the Main Agreement remain in effect.
