AMENDMENT/MODIFICATION NUMBER No. Six (0006)**

This Amendment/Modification Number Six (0006) ("Amendment/Modification") is made on the date of execution by the County and modifies Agreement/Contract Number 603-13-1 ("Main Agreement") between The Red Top Cab Company of Arlington ("Contractor"), and the County Board of Arlington County, Virginia ("County").

The Red Top Company of Arlington and the County entered into the Main Agreement for the Red Top Cab Company of Arlington to provide paratransit services.

Transportation, Inc., has assumed all of The Red Top Cab Company of Arlington rights and obligations in the Main Agreement. The Work and payment called for under this Amendment/Modification shall be subject to all terms and conditions of the Main Agreement unless specifically changed by the terms and conditions of an additional Amendment.

The County consents to the assignment of the Main Agreement to Transportation, Inc., commencing on the date of full executed of this Amendment/Modification. ("Effective Date")

The Main Agreement is therefore amended as follows:

1. The Red Top Cab Company of Arlington is in all instances replaced with Transportation, Inc.;
2. The term "Contractor" in the Main Agreement means Transportation, Inc.;
