ASSIGNMENT OF AGREEMENT/CONTRACT CONTRACT NO. 603-13-1 AMENDMENT/MODIFICATION NUMBER No. Six (0006)

This Amendment/Modification Number Six (0006) ("Amendment/Modification") is made on the date of execution by the County and modifies Agreement/Contract Number 603-13-1 ("Main Agreement") between The Red Top Cab Company of Arlington ("Contractor"), and the County Board of Arlington County, Virginia ("County").
