# **AGREEMENT NO. 22-CPHD-RFP-499** AMENDMENT NUMBER 1

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 22-CPHD-RFP-499 ("Main Agreement") dated December 7, 2022, between BU-GATA ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

- 1. PURSUANT TO PARAGRAPH 4. CONTRACT TERM, THIS AGREEMENT IS HEREBY RENEWED FROM FEBRRUARY 1, 2024 TO JANUARY 31, 2025. THREE (3) ONE (1) YEAR RENEWALS REMAIN.
