STATEMENT OF ISSUE: Consideration of Task Order 14 with Gator Boring & Trenching, Inc. (Gator Boring) per the terms of contract #C20-2905-WS for the installation of sub-surface directional bores on the Hwy 90 West Water Main Replacement project, to make connections with proposed potable water mains that run along the south side of Highway 90. This Task Order will be at a not to exceed cost of \$310,160.20.

BACKGROUND: As depicted on the attached map, the proposed portion of the project consists of approximately 6,300 linear feet (LF) of 10" water transmission main, 2,600 LF of 10" horizontally drilled directional bore, 1,300 LF of 6" water transmission main, and 200 LF of 6" ductile iron along Highway 90 from Antioch Road to Enzor Road. The above-mentioned new water mains will replace aging water mains, the majority of which are thin-walled PVC that has been subject to water main breaks over the last several years.

OCWS will be self-performing the construction of the above-mentioned project using OCWS staff and equipment to expedite completion of the project. A majority of the labor will be done by OCWS's in-house forces, but the horizontal directional bores will need to be performed by Gator Boring. OCWS will oversee Gator Boring's directional bores totaling approximate 2,600 LF of 10" fusible PVC water main.

TASK ORDER 14

THIS TASK ORDER IS ISSUED PURSUANT TO THE AGREEMENT FOR MISCELLANEOUS SUBSURFACE UTILITY BORES DATED JANUARY 10, 2020, BETWEEN THE COUNTY OF OKALOOSA COUNTY, FLORIDA AND GATOR BORING & TRENCHING, INC., WHICH IS INCORPORATED HEREIN BY THIS REFERENCE, WITH RESPECT TO

Scope of Basic Services for Okaloosa County Water and Sewer System Miscellaneous Subsurface Utility Bores

Article A. Purpose:

The purpose of this Task Order is to authorize and direct the CONTRACTOR (Gator Boring & Trenching, Inc.) to proceed with construction services for providing subsurface utility boring and utility installations services for the Okaloosa County Water and Sewer Department (OWNER) in accordance with contract C20 – 2905 - WS, dated January 10, 2020. The activities that are included are described in "Article B. Scope of Services."

Article B. Scope of Services:

The CONTRACTOR agrees to perform technical and construction related services in accordance with contract C20 – 2905 – WS, Section 00700, Article 7, dated January 10, 2020, that has been identified for Okaloosa County Water and Sewer System Subsurface Utility Bore Projects (PROJECT), as requested by the Owner's representative. The services that the CONTRACTOR agrees to furnish as part of this Task Order include, but are not limited to locating, verifying the location, excavation, material, boring, backfill, compaction, site restoration, erosion control, traffic control, record documentation and other associated work as referenced in the contract specifications. CONTRACTOR will have the appropriate equipment for the magnitude of this bore.

Article C. Compensation Provisions:

Scope will be billed to actual quantities installed, not-to-exceed the following
