A RESOLUTION ACCEPTING THE BID OF LATOUR **ECONOMY ELECTRIC** ENTERPRIZES. INC., D/B/A PROVIDE AS-NEEDED UTILITIES COMPANY, TO ELECTRICAL MAINTENANCE SERVICES AT HOURLY RATES AS SET FORTH IN THE BID, FOR A THREE-YEAR TERM WITH OPTIONS TO RENEW FOR TWO ONE-YEAR **TERMS CONTRACT** SUBJECT TO TERMS. CONDITIONS; APPROVING THE EXPENDITURE OF AN AMOUNT NOT TO EXCEED \$185,250 FOR SUCH SERVICES FOR REMAINDER OF FY 2017-2018; AUTHORIZING THE CITY MANAGER TO EXERCISE RENEWAL OPTIONS AND EXPEND SUCH FUNDS AS MAY BE BUDGETED DURING RENEWAL TERMS; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE GENERAL SERVICES TERM CONTRACT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, bids for as-needed utilities electrical maintenance services were duly called for and advertised; and

WHEREAS, all bids received were opened on December 4, 2017, and are listed on the schedule attached hereto and made a part hereof; and

WHEREAS, the Business Enterprise Management Director recommends acceptance of the bid submitted by LaTour Enterprises, Inc., d/b/a Economy Electric Company and the Chief Financial Officer has submitted a Sufficiency of Funds Certificate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission finds that the lowest and best bid submitted by a responsible bidder to provide as-needed utilities electrical maintenance services (at specified rates for a three year term with two one-year options to renew), is the following:
