**AGREEMENT NO. 22-DHS-EP-23  
AMENDMENT NUMBER 2**

This Amendment Number 2 is made on the 7/13/2023 and amends Agreement Number 22-DHS-EP-23 ("Main Agreement") dated July 1, 2021, between Volunteers of America, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

- 1. PURSUANT TO PROVISION 4, CONTRACT TERM, THIS AGREEMENT IS HEREBY RENEWED FROM JULY 1, 2023, THROUGH JUNE 30, 2024. THIS IS THE SECOND OF FOUR (4) SUBSEQUENT CONTRACT TERMS.**
- 2. REPLACE PROVISION 5, CONTRACT AMOUNT, AS FOLLOWS:**

The County will pay the Contractor in accordance with the terms of the Payment section below and up to a maximum of \$128,120.00 for service rendered to nine (9) Arlington County Residents living at two (2) VOA Group Homes in Arlington County as required by the Contract Documents. The Contractor shall bill Medicaid through Department of Medical Assistance (DMAS) for services provided to clients with DD Medicaid Waiver. The contract amount will be paid as follows:


- Base funding in the amount of \$69,120 per year (\$640.00 per month per resident) to cover expenses not reimbursed by Medicaid Waiver funding.
- A maximum of \$54,000 per year (\$500.00 per month per resident) for housing assistance.
- In the event one or more of the nine (9) Arlington County residents experiences a medical emergency that requires hospitalization, the Contractor, with prior approval from the County Project Officer, may provide companion care to the resident in the medical facility. The number of companion care hours reimbursed will be determined on a case-by-case basis. This service shall be reimbursed at the current DD Waiver Companion Care rate, currently \$21.79 per hour up to \$5,000.

Arlington County funds must be used in adherence to all Federal and Commonwealth of Virginia, Department of Medical Assistance Services regulations governing Home and Community Based Medicaid Waiver Services.


The County will not compensate the Contractor for any goods or services beyond those included in Exhibit A unless those additional goods or services are covered by a fully executed amendment to this Contract.

All other terms and conditions of the Main Agreement remain in effect.
