AMENDMENT NUMBER 2

This **Amendment Number 2** is made on the date of execution by the County and amends **Agreement Number 17-014-7-RFP**, dated **January 5, 2017**, ("Main Agreement") between **Danielle L. Burwell dba Better Speech Associates** ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor amend the Agreement as follows:

REVISE THE CONTRACT TERM PARAGRAPH TO READ AS FOLLOWS:

The Work will continue and must be completed no later than **December 31, 2020** ("First Subsequent Contract Term"), subject to any modifications provided in the Contract Documents. Upon satisfactory performance by the Contractor the County may, through issuance of a bilateral Amendment, authorize continuation of the Agreement not more than two additional 12-month periods, from January 1, 2021 to December 31, 2022 ("Second and third Subsequent Contract Terms").
