FIFTH AMENDMENT TO THE AGREEMENT BETWEEN OKALOOSA COUNTY AND MV TRANSPORTATION, INC. FOR PUBLIC TRANSPORTATION SERVICES CONTRACT NO. C19-2761-TS

This Fifth Amendment (this "Amendment") to Agreement between Okaloosa County, a political subdivision of the State of Florida ("County"), and MV Transportation, Inc., a Foreign Profit Corporation ("Contractor") is made and entered into as of January 2nd, 2024 (the "Effective Date"). County and Contractor may hereinafter be referred to collectively as the "Parties" and individually as a "Party."

RECITALS:

WHEREAS, the Parties have entered into that certain Agreement, dated December 18, 2018, Contract No. C19-2761-TS (as amended, the "Agreement"); and

WHEREAS, the Parties desire to amend the Agreement upon the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants, representations, and warranties contained in this Amendment, and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, the Parties, intending to be legally bound, agree as follows:

1. <u>Annual Hourly Volumes and Hourly Rates</u>. The County and Contractor hereby amend Section 5, Subset B of the original Agreement, and subsequent amendments, to reduce the annual service hours from 80,000 to 64,000 specifically impacting the paratransit/demand service:

Payments at the full rate shall be based on actual hours performed up to a maximum of 30,000 annual hours of fixed route service and for 34,000 annual hours of paratransit service. Payments at the variable rate shall be for any hours of service above the hourly thresholds above. In no circumstance shall Contractor be permitted to exceed 80,000 annual service hours, unless modified by the County in writing. Should Contractor exceed such cap on the annual service hours without first receiving a written modification from the County, it does so at its own risk and shall bear the full cost and expense.

The full rate shall be \$52.77 per hour. The variable rate shall be \$37.61 per hour.

If renewed for the last option year of the current agreement for calendar year 2025, the full rate shall be \$54.35 per hour and the variable rate shall be \$38.74 per hour. Any renewal shall be done subsequent to this amendment in writing and executed between the parties.

- 2. <u>Effective Date of Amendment</u>. The effective date of this amendment shall be retroactive to January 1, 2024.
- 3. <u>Effect on Agreement</u>. Except as specifically amended hereby, the terms and provisions of the Agreement, and any amendments thereto, are in all other respects ratified and confirmed and remain in full force and effect without modification or limitation.

- 4. <u>Governing Law</u>. This Amendment shall be governed by and construed under the laws of the State of Florida, without regard to principles of conflicts of law.
- 5. <u>Counterparts</u>. This Amendment may be executed simultaneously in one or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument. Faxed and e-mailed copies of manually executed signature pages to this Amendment will be fully binding and enforceable without the need for delivery of the original.
