

**AMENDMENT NO. 1 TO AGREEMENT FOR

This Amendment No. 1 hereby amends the Agreement effective October 1, 2022, by and between Okaloosa County, Florida ("County") and Air Force Armament Museum Foundation, Inc. ("Museum"), for Educating and Entertaining the Public ("Contract"), also known as County Contract No. C22-3253-TDD.

WHEREAS, quotes for signage were substantially higher than the estimated cost and advertising strategy was revised to run in the late fall and winter months; and


WHEREAS, both parties desire to amend the Contract to reflect funding for exhibit improvements and repair and maintenance.
