



Customer will, as a condition of allowing access to the Qualified Services and Qualified Devices, provide to each Patron (or his/her legal guardian, as applicable) a set of Customer-branded terms and conditions governing the use of the Qualified Services and Qualified Devices that (a) inform the Patron of Customer's privacy policy and data protection practices, (b) notify the Patron that data associated with provision of the Qualified Services will be used exclusively for the purpose of providing the Qualified Services, (c) advise the Patron that the Qualified Services and Qualified Devices are provided on an "as is" basis and that AT&T has no responsibility for Patron's use of the Qualified Device or Qualified Services, and (d) indicate that AT&T is a third-party beneficiary entitled to all rights and benefits afforded to Customer under Customer's terms and conditions as if AT&T were a party to such terms and conditions. With regard to each Patron (or his/her legal guardian, as applicable) participating in Customer's Library Connectivity Program, Customer is exclusively responsible for providing any notices, and obtaining any consents, that are required by law.

1.4.2.1 Location-Based Notices

Third party applications may allow the Qualified Devices used by Patrons to be location-enabled and thus tracked by the Customer. If Customer loads any such device tracking application on a Qualified Device, Customer is solely responsible for complying with all applicable legal requirements, including providing notice and obtaining opt in consent from the Patron (or his/her legal guardian, as applicable), and Customer will use such location information solely for the purpose of locating and retrieving Qualified Devices that are not timely returned to Customer. AT&T will not collect, use or otherwise have access to such location data, and Customer will not provide such location data to AT&T for any purpose.

1.4.3 Data

Customer represents and warrants that it has, and will maintain during the term of the Contract, an internet safety policy that addresses the following: (a) access by minors to inappropriate matter on the Internet and the World Wide Web; (b) the safety and security of minors when using electronic mail, chat rooms, and other forms of direct

electronic communications; (c) unauthorized access including "hacking" and other unlawful activities by minors online; (d) unauthorized disclosure, use and dissemination of personal information regarding minors; and (e) measures designed to restrict minors' access to materials harmful to minors. Specifically, Customer represents that devices will be loaned only to Patrons 18 years of age and older and that the Customer's device borrowing form will (1) include an acknowledgement by the patron that the device does not include any filtering software or other features for (x) restricting access to material on the Internet and the World Wide Web that may be harmful to minors, (y) preventing "hacking" and other unlawful activities by minors online, or (z) preventing unauthorized disclosure, use and dissemination of personal information regarding minors, and (2) require the Patron's agreement not to allow minors to access the internet using the device.

EXHIBIT A - AT&T ISE TERMS AND CONDITIONS

- 1. **DEFINITIONS.** The following terms have their corresponding meaning in this Exhibit A only. Capitalized terms undefined in this Exhibit A have the meanings ascribed to them in the Master Agreement and/or the PA.
 - 1.1. Affiliate of Contractor means any entity that controls, is controlled by, or is under common control with AT&T.
 - **1.2.** Base Station means a Contractor-owned base transceiver station (BTS) or any other device that generates RF.
 - 1.3. COAM means Participant-owned and maintained and Contractor approved.
- 1.4. Distributed Antenna System or DAS means Contractor-owned or COAM antennas mounted on the interior of abuilding that can provide enhanced RF coverage to the interior of the building, the corresponding electronics, the cabling, and any distribution system required to connect the antennas to the electronics.
 - 1.5. FCC means the Federal Communications Commission.
- **1.6.** Frequency or Frequencies means the frequencies for which a Contractor Affiliate holds a license from the FCC foruse in providing wireless telecommunication services and features.
- 1.7. Hazardous Materials means any substance or material capable of posing an unreasonable risk to health, safety or property or whose use, transport, storage, handling, disposal, or release is regulated by any law related to pollution, protection of air, water, or soil or health and safety.
- 1.8. Interference means undesired RF energy that can degrade the quality of Service on licensed frequencies, which may result in distorted conversations, dropped calls, and blocked calls for Contractor's licensed Affiliates or other carriers.
- 1.9. LAN means Local-Area-Network, which is a system that has networking equipment and/or computers in close proximity to each other capable of communicating, sharing resources and information
- **1.10. Modifications** means any modifications, enhancements, expansions, upgrades, adjustments, shut-downs, disablements, or other changes to a System or any component thereof.
- **1.11. Network** means the Contractor infrastructure that is used to provide wireless radio telecommunications services on the Frequencies.
- **1.12. Premises** means the individual, physical locations identified in an Attachment A, attached to one or more Purchase Orders issued by Participant and accepted by AT&T, a form of which is attached hereto as Attachment 1 (collectively, a "Purchase OrderAttachment").
 - 1.13. Repeater means a Contractor-owned or COAM bi-directional amplifier.
 - 1.14. RF means radio frequency.
 - 1.15. Section and "§" mean sections of this Exhibit, unless otherwise noted.
- **1.16. Service** means commercial mobile radio service, including without limitation wireless voice telecommunications services and wireless data telecommunications services.
- **1.17.** Small Cell means a high capacity, low power small cell radio that generates RF for the purpose of extending Networkcoverage.
- 1.18. System means a customized in-building wireless radio telecommunications system comprised of one or more Base Station(s) or Small Cell or Repeater(s) (as applicable), the DAS (Contractor-owned or COAM), any related transmission facilities and anyrelated equipment and cabling that will be installed for use on the Premises, as further described for each particular Premises in a Purchase Order Attachment, to enable enhanced RF coverage from the Network.



- **1.19. Transport** means the public telecommunications infrastructure that permits telecommunications between and among defined Network termination points. (e.g., Ethernet, Power over Ethemet, Microwave).
- **1.20.** WAN means Wide Area Network, a private or public network service generally provided by a telecommunications carrier that connects LANs across diverse geographic regions.
- 1.21. Wi-Fi means a technology that allows electronic devices to connect to a wireless LAN network and has Access Pointsand Controllers.

SYSTEMS AND PREMISES.

- 2.1. Identification. The Parties acknowledge and agree that a unique System will be required for each of the Premises identified in a Purchase Order Attachment. These Premises will be identified in chronological Purchase Order. Similarly, the corresponding Systems, along with any installation fees, equipment removal fees, and other System- specific issues will be described in a completed Attachment A. The Parties acknowledge and agree that by mutual agreement they may add additional Systems to existing Premises. All terms and conditions of this Exhibit A apply to each and all such Purchase Orders issued pursuant to this Exhibit A. If there is any material conflict, the terms and conditions of each Attachment take precedence over the terms and conditions of the remainder of this Exhibit A.
- **2.2. Design.** Each System includes a corresponding design that is mutually agreed upon by the Parties (each, a "Design") after receipt of the Participant's order.
- **2.3.** Installation. Contractor will install the Contractor-owned components of each System on the corresponding Premises in accordance with the corresponding System design(s). Related fees for the System(s), if any, are set forth in each Premises' corresponding Purchase Order Attachment.
- 2.4. Ownership. FCC regulations require Contractor to maintain sole control over any transmitting device that operates within Contractor's assigned Frequencies. The Parties agree that except with respect to a COAM DAS or COAM Repeater (if applicable): (a) Participant does not have, and will not acquire through the Agreement, any proprietary or ownership rights or interest in any Contractor equipment, the Network, Contractor's cell sites and related components, the Frequencies, or the public revenues associated with the Service or any Contractor equipment, (b) all Contractor equipment, and all corresponding components, are and will remain the property of Contractor, and (c) Contractor will have the right to install, operate, monitor and remove any Contractor-owned equipment in its sole discretion at Contractor's expense. Contractor has no proprietary or ownership rights in the Premises or Participant's facilities, including Participant-owned cabling and distribution systems, including the COAM DAS and/or COAM Repeater (if applicable) used as part of an installation.
- **2.4.1.** Non-Exclusive Use of Base Station(s). Participant understands, acknowledges and agrees that, if a System includes one or more Base Stations, Participant's right to use the Base Station(s) is non-exclusive. Contractor may use any and all such Base Stations in connection with one or more separate Participant's(s') systems.
- 2.5. Maintenance and Monitoring. If a System does not include a COAM DAS or COAM Repeater, then Contractor will maintain that System at Contractor's expense provided that replacement parts are reasonably available. If the System doesinclude a COAM DAS or COAM Repeater, then Participant will maintain any such COAM DAS and/or COAM Repeater at Participant's expense and Contractor will maintain the Contractor-owned System components, at Contractor's expense provided that replacement parts are reasonably available. Notwithstanding the foregoing, Contractor will not maintain nor will it pay for any cabling related to a System damaged by Participant. Due to Contractor's ownership rights and FCC requirements, Contractor has the right to monitor the operation of a System twenty-four hours per day, seven days per week, in order to determine System performance and to ensure that Participant and/or a System does not cause Interference to other Contractor Participants or their users, the Network, transmission facilities or other equipment. Contractor will determine the cause of any Interference it identifies in the vicinity of a System and may, at its option, disable or shut down such System until Contractor is able to determine and eliminate the cause of the Interference. In the event Contractor intends to exercise its option to disable or shut down a System, then Contractor will provide Participant reasonable notice of the related processes.



- 2.6. Capacity and Modification. Participant understands and agrees that a System impacts Network capacity and performance, and that, due to the nature of RF, a System may not provide coverage for the entire corresponding Premises. Participant will use reasonable good faith efforts not to change the Premises or Participant's use of the Premises in any way that interferes with the Frequencies, any System, or the Network. Participant understands and agrees that with reasonable prior notification to Participant (a) Contractor may, in its sole discretion, propose and make Modifications to the Contractor components of a System at Contractor's Expense; and (b) any such Modifications may require additional space and consume additional power at the Premises. Furthermore, If
- (i) a planned Modification involves an expansion of the Contractor components of a System or otherwise requires additional space and/orpower or (ii) the DAS is COAM and does not support the Modification; and/or (iii) Participant objects to the Modification; or (iv) Participantchanges the Premises or use of the Premises in a manner that interferes with the Frequencies, a System or the Network; and (v) no reasonable solution can be found, then Contractor may, at its option (A) disable or shut down the Contractor components of the impacted System at any time, and/or (B) remove the Contractor-owned portions of the System in accordance with this Exhibit. Any Participant-proposed Modifications or COAM DAS expansions to a System are subject to Contractor's prior written approval, and, if approved, will be implemented at Participant's sole expense using a vendor approved by Contractor. Nothing in this §2.6 will affect Contractor's rights under §2.8.
- 2.7. Connectivity. Participant understands and agrees that if a System includes a Base Station, then the Base Station requires connectivity to the Network via telephone company transport facilities, and Contractor will provide such connectivity at Contractor's expense. Participant understands and agrees Small-Cells require Transport. If Participant is responsible to provide Transport it must be available on a 24 hour, seven 7 day a week basis and maintained in good condition and repair. Participant acknowledges and agrees that failure to support the provision of the Transport as set forth herein will prevent the System from operating.
- 2.8. Contractor Access. When accessing the Premises to complete any necessary installation, maintenance, repair, replacement, removal or other Modifications of any System, Contractor agrees to be subject to Participant's reasonable security procedures and protocol.
- 2.9. Use of Third Parties. Participant understands that Contractor may install, maintain, make Modifications to, monitor, remove and otherwise provide and operate a System under this Exhibit using Contractor's Affiliates and/or third-party subcontractors, and, accordingly, all references to "Contractor" in this Exhibit will include any such Affiliates and subcontractors.
- PARTICIPANT RESPONSIBILITIES. Participant represents and agrees that:
- 3.1. Participant will obtain, prior to installation and at no cost to Contractor, all required approvals, licenses, permits, right of way, permitted use and consents from any and all applicable parties (including but not limited to landlords) to allow Contractor to install, maintain, repair, replace, remove, make Modifications to, and/or operate a System on the corresponding Premises. For clarification, Contractor will obtain, at no additional cost to Participant, all approvals, licenses, permits and consents required by the FCC, the respective State Public Utilities Commission or any other regulatory agency for the operation of the Contractor-owned components of the System.
- 3.2. Except as otherwise set forth in §2.7 (Connectivity), Participant will provide to Contractor, at no cost to Contractor, any conduit, holes (including without limitation any roof penetrations), wire ways, fiber wiring between buildings and floors, power/utilities and other items reasonably required to allow Contractor to install, repair, maintain, replace, remove, make Modifications to, and/or operate a System. Participant is responsible for any necessary extension of the telecom/data circuit from the demarcation point to the location where a Base Station or Small-Cell is deployed. Moreover, Participant agrees to reasonably cooperate with Contractor with the provision of such items, including but not limited to Transport, within a reasonable time.
- **3.3.** Participant will provide to Contractor, at Participant's sole cost, all electrical circuits and electricity, space in and on the corresponding Premises in accordance with Exhibit A that is sufficient, climate controlled, and in such a condition that will allow Contractor to install, repair, maintain, replace, remove, make Modifications to (subject to §2.5), and/or operate the corresponding System.
 - 3.4. Participant will ensure that the Premises at which Contractor installs and maintains Contractor-



owned equipment is asuitable and safe working environment, free of Hazardous Materials. Contractor does not handle, remove or dispose of Hazardous Materials, and Contractor has no obligation to perform work at any Premises that is not a suitable and safe working environment. Contractor will not be liable for any Hazardous Materials.

- 3.5. Participant will identify and make available to Contractor an authorized Participant representative to notify for gaining access to all Systems, and will provide Contractor with access to all Systems and any COAM DAS and/or any COAM Repeater as follows:
- **3.5.1.** Standard business hours for installation, maintenance, removal, replacement and certain Modifications (as reasonably determined by Contractor); and
 - 3.5.2. 24 hours per day, seven 7 days per week for emergency repairs as mutually agreed upon.
- **3.6.** Participant will ensure that all installation, modification, handling, maintenance, repair, removal of, and/or Modification to Contractor-owned components of a System are performed solely by Contractor or a Contractor approved subcontractor.
- 3.7. Participant will not allow any other wireless carrier to use a Contractor-owned System or any Contractor-owned component of a System.
- **3.8.** To the extent authorized by and in accordance with Chapter 53 of the Connecticut General Statutes, Participant will be solely responsible for all costs to repair Contractor-owned components of a System from damage caused by acts or omissions of Participant, its agents, employees, Contractors, or invitees.
- **3.9.** Participant will be solely responsible for all costs associated with a remodeling of a premises that alters the DAS and/orwith moving a System within the corresponding Premises to a new location, if such move is done at Participant's request, and all such moves will be subject to Contractor's written approval which will not be unreasonably withheld.
- **3.10.** Participant will not install or operate a Repeater on any Premises to broadcast the Contractor Frequencies without Contractor's consent.
 - 3.11. Participant will notify Contractor of its intent to vacate any Premises at least 60 days prior to such vacancy.
 - Participant will provide rack space within its tenant space in the corresponding Premises.
- **3.13.** To the extent it deems necessary, Participant will provide escorts when any Contractor personnel or agent is on the corresponding Premises in accordance with this Exhibit at no cost to Contractor.
- 3.14. If Participant operates a DAS or other RF transmitter at the Premises (collectively "Premises DAS") with Contractor's Frequencies, Participant (i) will be responsible for complying with the FCC RF exposure regulations, including as set forth in FCC OET- Bulletin 65 "Evaluating Compliance with FCC Guidelines for Human Exposure to Radiofrequency Electromagnetic Fields," when operating the Premises DAS or other transmitter; (ii) will operate the Premises DAS in full compliance with those FCC RF exposure regulations; (iii) will, upon reasonable request, provide Contractor with proof that the Premises DAS and all other transmitters comply with the FCC RF exposure regulations; and (iv) will run an RF exposure analysis at the initial operation of the Premises DAS and/or other RF transmitter(s) with Contractor Frequencies, and at any modification of that equipment, to confirm compliance with the FCC RF exposure regulations. Participant's failure to comply with these requirements is a material breach of its obligations, and any such breach will permit Contractor to initially halt delivery of Contractor's RF signal service to the Premises DAS or other transmitter(s) and suspend or terminate Participant's permission to transmit Contractor's Frequencies on the Premises DAS or other transmitter(s).
- 4. ADDITIONAL TERMINATION RIGHTS AND REMEDIES. Contractor may immediately terminate this Exhibit A and cease provisioning any and all Systems hereunder and exercise any and all other remedies available at law or in equity to the extent in accordance with AT&T termination rights and obligations in the Master Agreement. In addition, Contractor may shut down the Contractor-owned components of any and all applicable Systems under the following circumstances:



- **4.1.** Regulatory Change. In the event the FCC, the respective State Public Utilities Commission or any other regulatory agency or legislative body promulgates any rule, regulation or order that in effect or application prohibits or adversely affects Contractor's ability to fulfill its obligations hereunder.
 - **4.2. Interference.** In the event Contractor is unable to eliminate the cause of any Interference identified pursuant to §3.6.1 Monitoring, regardless of the cause.
 - 4.3. Vacancy. In the event Participant vacates any Premises.
 - **4.4. Operations.** In the event Contractor experiences a significant loss of Participant provided power or Transport.

5. EQUIPMENT REMOVAL; FEES.

- 5.1 If Contractor terminates this Exhibit and/or provisioning the ISE System for any reason, then Contractor has the additional right to enter the Premises and remove any and all Contractor-owned System or Contractor-owned component of a System upon reasonable notice to Participant, provided, however that this right extends only to the corresponding Premises.
- 5.2 To the extent any equipment removal fees apply at a specific Premise, they are detailed in a Purchase Order Attachment and Participant must pay such equipment removal fees. Furthermore, equipment removal fees detailed in Purchase Order Attachment may apply if: (1) Contractor terminates the PA and/or the Agreement; (b) Contractor terminates the PA and/or the Agreement pursuant to §4.2 above where Contractor determines that the Interference is caused by Participant or its use of the Premises; and/or (c) Contractor terminates the PA and/or the Agreement pursuant to §§4.3 and 4.4.
- 6. COMPLIANCE WITH FCC RULES AND REGULATIONS. Contractor is a wireless carrier that uses federally licensed spectrum and is subject to rules and regulations of the Federal Communications Commission (FCC). The FCC has published specific regulatory guidelines as to the maximum permissible exposure (MPE) of radio frequency (RF) emissions. In connection with Contractor's installation of the equipment to be installed pursuant to this Exhibit at Participant locations, there may be circumstances when applicable FCC rules require Contractor to implement precautionary measures to implement safety protections for the benefit of the public relating to RF emissions. These include but are not limited to the placement of visible signage and/or physical barriers near the equipment's antenna. Participant hereby grants and/or will obtain for Contractor the right to post all required signage, place all barriers and otherwise comply with the applicable FCC regulations at all locations where Contractor installs the equipment to be installed pursuant to this Exhibit A.
