Material specifications and other procedures relevant to the SOE will be included in the General Notes of the construction drawings.

Task 2: Comment Review Matrix

The Developer shall submit two in-progress SOE design packages to the County and WMATA for review and comment: SOE Design Package No. 1 and SOE Design Package No. 2. The Developer shall address comments received from the County and WMATA. The Developer shall develop a comment review matrix to record and resolve comments received by the County. WMATA to the County will approved the comment resolution. The Developer shall submit a final SOE Design Package for the County and WMATA approval.

- 5. Final Comment Review Matrix.

Period of Performance:

Crystal City Metrorail Station East Entrance Project JBG SMITH INTERIM AGREEMENT AMENDMENT EXHIBIT A – SCOPE OF SERVICES

Introduction

With the understanding that WMATA's JDAC review process could have a significant impact on the future Comprehensive Agreement Design-Build (D-B) Phase schedule, it is recommended to advance the design of the support of excavation (SOE) beyond that currently planned in the Interim Agreement.

The preliminary ground surface elevation varies from EL. 36 at the 18th Street to EL. 44 at the southern edge of the existing underground station. Planned elevation of the new mezzanine is approximately EL. 9 (or EL 7 when accounting for a 2' thick slab allowance) and the south side elevator pit side will be approximately EL 3 (or EL 1 when accounting for a 2' thick slab allowance). Based on the current station platform elevation, the planned elevation of the new platform is estimated to be EL. -2 (or EL -4 when accounting for a 2' thick slab allowance) and the elevator pits along the north side adjacent to the station will be approximately EL -8 (or EL -10 when accounting for a 2' thick slab allowance). The main excavation depths are estimated as follows:

- Mezzanine: 37 ft (EL 44 minus EL 7)
- > South Side Elevator Pit: 35 ft (EL 36 minus EL 1)
- > Platform: 48 ft (EL 44 minus EL -4)
- North Side Elevator Pit: 54 ft (EL 44 minus EL -10)
- > Street Access Stairway at East: varies from 0 ft to 32 ft

The new entrance structure will tie into the existing station at two locations. The opening at the new mezzanine level will be approximately 12 ft wide, and the opening at the existing platform level will be approximately 6 ft wide. We estimate that there will be approximately 5 ft between the existing station vault structure wall and the proposed new east entrance structure wall.

12.10 Support of Excavation

The JBGS Team will advance Support of Excavation (SOE) to approximately 100% design completion with the development of structural design and supporting construction drawings for submission to WMATA for review through the JDAC process. Material specifications and other procedures relevant to the SOE will be included in the General Notes. The JBGS Team will submit up to two (2) rounds of submittals for Arlington County and WMATA review, with the plans being revised each time to address comments received.

Assumptions/Exclusions

- WMATA will provide loads as the basis of the design and the loading criteria for the existing structure.
- 2. A soldier pile and lagging wall system is acceptable to WMATA for use as the SOE system as previously discussed with them, particularly adjacent to the existing Station.
- 3. Structural and/or analysis of existing station is excluded from this scope as the focus is entirely on the SOE system.
- 4. A vibration and construction monitoring program is excluded from this scope as that is more appropriate for the Comprehensive Agreement D-B Phase.
