AGREEMENT NO. 514-12  
AMENDMENT NUMBER 7

This Amendment Number 7 is made on the date of execution by the County and amends Agreement Number 514-12 dated June 30, 2011, ("Main Agreement") between **Community Living Alternatives Corporation, 9401 Lee Highway #406, Fairfax, Virginia 22031** ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor amend the Contract Term and Contract Pricing called for under the Main Agreement as follows:

3. AMEND CONTRACT TERM TO READ AS FOLLOWS:

The Contract Term shall continue from July 1, 2018 through June 30, 2019. This is the SEVENTH of a possible NINE 12-month renewal of the ('Subsequent Contract Terms').

4. AMEND CONTRACT AMOUNT AS FOLLOWS:

See attached amended Exhibit B ("Contract Rates").

All other terms and conditions of the Main Agreement remain in effect.

**CONTRACT RATES**

**RATES**

**FISCAL YEAR 2018:**

The County will add an additional \$2,860.00 to the contract from the group home emergency medical fund to support an individual following a medical procedure requiring overnight supervision.

**FISCAL YEAR 2019:**

The County will add funding for ongoing overnight supervision and pay the Contractor **\$262.28 per day** for each of the three (3) Arlington clients in the Supervised Apartment Setting, up to a maximum of 1,098 Bed Days, up to a **maximum of \$ \$287,197.00** per year.

The County will also pay an additional \$4,200 per resident per (\$350 per resident per month) for housing assistance, not to exceed a maximum of \$12,600 total.

Clients shall not pay more than 30% of their income on housing and this shall be reflected in their residential fee agreement. The current residential fee agreement shall be received by Arlington County ID services in order for the Contractor to bill for rental assistance.

The County will reduce the monthly payment for discharged or attritioned County clients at the rate of \$262.28 per day per resident and \$350 per resident per month.

Arlington County funds shall be used in adherence to all Federal and Commonwealth of Virginia regulations governing residential programs that are licensed by DBHDS.
