### AGREEMENT NUMBER 430-10

#### AMENDMENT NO. 1

This Amendment Number 1 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement Number 430-10 dated June 28, 2011 ("Main Agreement"), made between The Animal Welfare League of Arlington, Virginia, Incorporated ("Contractor"), a Virginia non-stock and non-profit corporation authorized to do business in the Commonwealth of Virginia, and the County Board of Arlington County, Virginia ("County").

WHEREAS the County and the Contractor desire to amend the Work called for and the amounts to be paid pursuant to the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows:

I. THE FOLLOWING SENTENCE IS ADDED TO SECTION 7, CONTRACT AMOUNT, OF THE MAIN AGREEMENT AFTER THE SENTENCE THAT READS: "The Contract Amount includes all of the Contractor's reimbursable costs, expenses, and fees."

"During FY 2012, the County will pay to the Contractor, in addition to the Contract Amount set forth above, a one-time payment in the amount of Thirty-Five Thousand Dollars (\$35,000) to aid the Contractor in meeting increased infrastructure and equipment costs."

The work and payment called for pursuant to this Amendment shall be subject to all terms and conditions of the Main Agreement. All terms and conditions of the Main Agreement shall remain in full force and effect unless specifically changed by this Amendment.
