Increase the required Living Wage as required by the Paragraph 56 Terms and Conditions from • \$14.50 to \$15.00 per hour. This rescinds the clarification made in Addendum A to the solicitation that stated that the 14.50 rate will be applicable throughout the entire contract duration.
