AGREEMENT NO. 17-169-RFP AMENDMENT NUMBER 1

This Amendment Number 1 is made on July 9, 2020 and amends Agreement Number 17-169-RFP ("Main Agreement") dated July 2, 2018 between Architecture, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").
