**AGREEMENT NO. 17-169-RFP
AMENDMENT NUMBER 1**

This Amendment Number 1 is made on July 9, 2020 and amends Agreement Number 17-169-RFP (“Main Agreement”) dated July 2, 2018 between Architecture, Inc. (“Contractor”) and the County Board of Arlington County, Virginia (“County”).

The County unilaterally amends the Contract Term called for under the Main Agreement by replacing the Contract Term with:

4. Contract Term

The term of this Agreement will commence on the date of execution and shall be completed no later than November 30, 2023 (“Initial Contract Term”), subject to any written modifications as provided for in the Contract Documents. Work through the completion of the Construction Documents Phase, defined in Attachment A, will be completed no later than June 30, 2019 and Contract Administration services shall continue through November 30, 2023. The Bidding and Award phase will begin with the County’s issuance of the Invitation to Bid for Constructions Services. The Construction Administration and Closeout Phases will begin upon the award of the Construction Contract between the County and the Construction Contractor and terminate upon completion of the Final Completion Inspection, final LEED Submittal and any other tasks require for the construction project closeout.

All other terms and conditions of the Main Agreement remain in effect.
