Enclosed is the 2023 loan renewal package for the historical property on loan to your organization from the National Museum of the United States Air Force (NMUSAF). The required actions should be completed and returned to the National Museum of the United States Air Force no later than 31 March 2023.

As you may recall from last year, we entered a multi-year loan agreement that spans from 1 April 2022 to 31 March 2024. The 2024 loan renewal cycle will be for five years – 2024-2029. From then on it will remain a five-year cycle, renewing the 4^{th} and 9^{th} year of each decade.

There is an annual requirement that the Department of the Air Force ensures that each loan account verify that the property in their care is being used for approved purposes, is being maintained and protected according to the loan agreement, and that the borrowing organization still desires to retain the property. To fulfill this requirement NMUSAF requires the return of the completed inventory report and POC sheet. Please see these attached documents.

To complete the inventory report: physically inspect of each item on loan, verifying the nomenclature against the report. Annotate any discrepancies such as additions (attached munitions), shortages, damage, or deterioration. Upon completion of the physical inspection, sign and date the Certification Statement on the inventory.

To complete the point of contact information sheet: Review the Point of Contact Information sheet and make handwritten changes to update the information, **do not retype the page**. Explanations of several items on the Point of Contact Information Sheet are listed below:

- <u>The Historical Property Custodian</u>: The individual authorized to obligate the organization is the Historical Property Custodian (no exceptions).
- <u>Primary Point of Contact, Title Primary Point of Contact & Primary Phone Number</u>: This is the individual that you want to receive any correspondence from the National Museum of the USAF and can answer any questions about the items on loan. This individual may be different from the Historical Property Custodian.
- <u>Email Address</u>: This is the email address for all correspondence. Please consider making this an organizational email address.
