AGREEMENT NO. 21-DHS-EP-2**

**AMENDMENT NUMBER 1
ASSIGNMENT OF AGREEMENT**

This **Amendment Number 1** (“Amendment”) is made on **January 15, 2021** and amends **Agreement Number 21-DHS-EP-2** (“Main Agreement”) between **Bonder and Amanda Johnson Community Development Corporation**, 2229 S. Shirlington Road, Arlington, Virginia 22206 (“Contractor”), and the **County Board of Arlington County, Virginia** (“County”).

Bonder and Amanda Johnson Community Development Corporation and the County entered into the Main Agreement for Bonder and Amanda Johnson Community Development Corporation to operate the Green Valley Community Center.

Bridges to Independence, Inc. has assumed all of Bonder and Amanda Johnson Community Development Corporation rights and obligations in the Main Agreement. The work and payment called for under this amendment shall be subject to all terms and conditions of the Main Agreement unless specifically changed by the terms and conditions of an additional amendment.

The County consents to the assignment of the Main Agreement to Bridges to Independence, Inc. beginning on January 15, 2021 (“Effective Date”).

The Main Agreement is therefore amended as follows:

1. Bonder and Amanda Johnson Community Development Corporation is in all instances replaced with Bridges to Independence, Inc.;
2. The term “Contractor” in the Main Agreement means Bridges to Independence, Inc.;
