



**FIRST AMENDMENT TO THE AGREEMENT BETWEEN OKALOOSA  
COUNTY, FLORIDA AND  
GLAZE COMMUNICATIONS SERVICES, INC.  
CONTRACT NO. C22-3125-IT**

This First Amendment to the Agreement between Okaloosa County, a political subdivision of the state of Florida (the "County"), and Glaze Communications Services, Inc. executed this 1st day of October, 2021, is made a part of the original Agreement dated July 6, 2021, Contract No. C22-3125-IT (the "original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

1. Section 2.3 of the Agreement shall be amended to reflect a new hourly rate for 1 Man Crew from \$58.00 per hour to \$59.22 per hour. The rate increase is listed in Exhibit "A" attached hereto and made a part of the Agreement.

2. The Agreement shall be amended to add the following:

In the event additional material or personnel pricing is required it will be at fair market value in accordance with industry standards unless otherwise stated in this document or negotiated and approved by the County.

3. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated July 6, 2021 and any amendments thereto, shall remain in full force and effect.

4. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.

**Subject: Glaze Communications Services, Inc. Labor Rate Increase Request for RFP 180206 - Video Surveillance Security Systems**

Mr. Doug Taylor,

The District received your request dated March 8, 2021 to increase the labor rates by the amounts listed in the table below. According to RFP 180206, Section V (Special Conditions), Letter C (Miscellaneous), Item 7, Paragraph one (1), "Beginning on the second Agreement year, and each Agreement year thereafter (including additional renewal terms), adjustments to labor rates will be negotiable and limited to the appropriate Consumer Price Index for All Urban Consumers (CPIU): Selected areas, all items index for South urban: Size B/C as published by the US Department of Labor, Bureau of Labor Statistics"

The difference of the CPI-U, South-Size from February 2020 to February 2021 is an increase of 2.1% . Based on this increase, the District is willing to adjust the hourly bill rates, as shown in the table below. The increased rate would take effect at the beginning of the renewal Term of the Agreement.
