Pursuant to paragraph 2 of the Contact documents, the City of Daytona Beach hereby gives notice that it desires to renew the first of two Contract renewal options for the term of 1 year(s) beginning October 3, 2018 and ending October 2, 2019. Contract states the vendor's right to submit proposed price increases for the renewal period, based solely upon increases in Vendor's costs, such as material costs, with accompanying cost data, within a 180 days prior to renewal, to take effect at the renewal date. The City agrees to the increased unit price of \$150.00 per ton, an increase of 12% over the initial price.

Yes, so Morton re-evaluated ALL of our B2B products in regards to this price increase. Our Operations team has been working closely with our plants to determine how we can ramp up production to successfully meet the increasing demand we have year to year. Our plants aren't necessarily equipped to handle what we need to produce. Therefore, we are making capital investments into our plants which is why you're seeing a 12% increase on salt.

In regards to freight, we have not updated our freight rates with our carriers since about 2015. In order to stay competitive in the marketplace, we had to re-align our pricing hence the 12% increase on freight.

I hope this helps better understand the price increase, and please let me know if you have any questions.
