

AMENDMENT NUMBER 10

PREVIOUS CONTRACT NUMBER 256-07

This Amendment Number 10 (Amendment) is made on the date of execution of the Amendment by the County and amends Agreement Number 293-11, as amended by Amendment No. 1 through 9 (Main Agreement) made between Ethiopian Community Development Council, Inc., 901 South Highland Street, Arlington, VA 22204 ("Contractor") and the County Board of Arlington County, Virginia (County).

Whereas the County and the Contractor desire to amend the Contract Term under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows.

1. REVISE THE CONTRACT TERM:

The Contract Term shall be from the date the Agreement is executed by the County through **June 30, 2018** (Fiscal Contract Year) and will continue thereafter until the County board of Arlington County no longer authorizes funds for the services covered by this Contract. Each successive Contract Year in which the County Board authorizes funds shall cover the period from July 1 through June 30.

2. CONTRACT AMOUNT PARAGRAPH TO READ AS FOLLOWS:

The County will pay the Contractor no more than **\$140,573.00** in accordance with the terms of the Payment paragraph and Exhibit A and B for the Contractor's completion of the Work described and required in the Contract Documents subject to the terms and conditions in those documents. The Contractor agrees that it shall complete the Work for the total Contract Amount specified in this section unless such amount is modified as provided in this Agreement. The Contract Amount includes all of the Contractor's costs and fees (profit).

TERMS AND CONDITIONS

All terms and conditions of the Agreement shall remain in full force and effect for the work covered by this Amendment unless specifically changed by the terms and conditions of this Amendment.
