

**AMENDMENT NO. 1 TO AGREEMENT BETWEEN OKALOOSA COUNTY, FLORIDA
AND MILES PARTNERSHIP, LLLP
WEBSITES DESIGN, BUILD AND MAINTENANCE**

CONTRACT # C22-3169-TDD

This Amendment No. 1 hereby amends the Agreement effective April 5, 2022, by and between Okaloosa County, Florida ("County") and Miles Partnership, LLLP ("Contractor"), for Okaloosa County Tourist Development Department Websites Design, Build and Maintenance ("Contract"), also known as County Contract No. C22-3169-TDD.

WITNESSETH:

WHEREAS, the Contract provides two options for CRM licensing; and

WHEREAS, staff has worked with the vendor to identify the most appropriate licensing structure based on functionality and number of users; and

WHEREAS, both parties desire to amend the Contract to reflect 13 users per month at a cost of \$112.50 per user.

NOW THEREFORE, in consideration of the mutual covenants herein and other good and valuable consideration, the parties hereby agree to amend the Contract as follows:

1. Exhibit A shall be amended as follows:

2. This Amendment No. 1 shall be effective upon execution by the County.

3. All other provisions of Contract # C22-3169-TDD shall remain in full force.


