AMENDMENT NUMBER 6

This Amendment Number 14 is made on the date of execution by the County and amends Agreement Number 244-11, dated June 1, 2011, ("Main Agreement") between Northern Virginia Family Services, 10455 White Granite Drive, Oakton, Virginia 22124 ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor amend the Contract Amount called for under the Main Agreement as follows:

**REVISE THE CONTRACT TERM AND PARAGRAPH TO READ AS FOLLOWS:**

The contract term shall continue from July 1, 2019 through June 30, 2020 (Fiscal Contract Year).

**REVISE THE AGREEMENT NUMBER TO READ AS FOLLOWS:**

The agreement number is hereby changed from 244-11-X to 244-11-EP to continue identification as an Exempt Purchase Agreement under EP30: Goods and personal services for direct use by individual recipients of public assistance programs as defined in section 37.1-1 of the Code of Virginia.
