**AMENDMENT NUMBER 1  
ASSIGNMENT OF AGREEMENT**

This **Amendment Number 1** (“Amendment”) is made on the date of execution by the County and amends Agreement Number **22-DES-SLA-442** (“Main Agreement”) between **Infrastructure Technologies, LLC dba ITpipes** (“Contractor”) and the County Board of Arlington County, Virginia (“County”).

The County and the Contractor agree to amend the Main Agreement as follows:

- 1. CHANGE THE CONTRACTOR’S NAME “INFRASTRUCTURE TECHNOLOGIES, LLC DBA ITPIPES” TO “ITPIPES OPCO, LLC” IN ALL INSTANCES.**
- 2. PURSUANT TO PARAGRAPH 4. CONTRACT TERM, THIS AGREEMENT IS HEREBY RENEWED FROM OCTOBER 1, 2023 TO SEPTEMBER 30, 2024.**
- 3. REMOVE PARAGRAPH 17. COVID-19 VACCINATION POLICY FOR CONTRACTORS.**


**5. REMOVE EXHIBIT D: CONTRACTOR COVID-19 VACCINATION CERTIFICATION.**


