## Okaloosa County Information Technology Agreement for Exclusive Use of Optical Fiber Contract Number C23-3283-IT

Fiber Task Order 8, Meet-me Indian Bayou Trail & Emerald Coast Pkwy

This Fiber Task Order is issued pursuant to the Agreement for Exclusive Use of Optical Fiber dated December 6th, 2022, between Okaloosa County, Florida (PROVIDER) and LiveOak Fiber, LLC (CUSTOMER) which is incorporated herein by this reference, with respect to:

Scope of Services

For

Okaloosa County Information Technology Exclusive Use of Optical Fiber

#### **PURPOSE**

The purpose of this Fiber Task Order is to outline activities to be completed by the PROVIDER, at the CUSTOMER's request. Said activities are outlined in "Scope of Services." This Fiber Task Order also provides "Compensation Provisions" to advise CUSTOMER of the costs associated with the activities to be performed.

TERM 10 years to align with Fiber Task Order 1

**DUE DATE** August 4, 2023

### SCOPE OF SERVICES/COMPENSATION PROVISIONS

Splicing/Meet-me Demarcation Costs: PROVIDER will construct or install and provision to CUSTOMER up to a 48-count CUSTOMER-provided SM Fiber Optic Cable (FOC) in a PROVIDER-installed 2" HDPE or other suitable conduit to handhole, pull box or other suitable endpoint provided and installed by CUSTOMER. This CUSTOMER handhole will be the demarcation between the PROVIDER Network and the CUSTOMER Network. The specific demarcation will be the entry point of the FOC/conduit at the CUSTOMER handhole.

- 1. Fixed Non-Recurring Cost (NRC) Cost: \$10,000 for each Meet-me PROVIDER network tie-in location. This includes necessary actions to connect the Meet-me to the CUSTOMER network.
  - 1.1. Meet-Me location on the W Corner of Indian Bayou Trail & Emerald Coast Pkwy, Destin, Florida as close as possible to PB 5164.
  - 1.2. Per contract agreement, a one-time build cost of \$ 10,000.00 will apply.
  - 1.3. 50% at execution of Fiber Order and remainder due upon Acceptance.
- 2. Variable (NRC) Cost: \$25 per Linear Foot (LF) to construct Meet-me tie in between PROVIDER splice enclosure to CUSTOMER handhole. Meet-me fiber will be tested, coiled with a minimum of 50 LF of storage, and capped in CUSTOMER handhole.
  - 2.1. 100 LF @ \$25 = \$ 2,500.00
  - 2.2. 50% at execution of Fiber Order and remainder due upon Acceptance.
- 3. Additional costs for special conditions if necessary, upon agreement by both Parties.

- 4. Additional Maintenance Yearly Recurring Cost (YRC): based on linear footage to install Meetme will be prorated and added to yearly fiber maintenance in accordance with the Yearly Recurring Cost provisions.
  - 4.1. 100 LF = 0.019 miles @ \$1,200/mile = \$22.80/year
