Remove the following locations from the service agreement:

Engineering Modular Building, 1808 Lewis Turner Blvd	\$61.20 annually

Add the following locations to the service agreement:

Field Offices, 1802 Lewis Turner Blvd	\$1,620.00 annually
Maintenance Building, 1810 Lewis Turner Blvd	\$216.00 annually

2. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated December 21, 2020, and any amendments thereto, shall remain in full force and effect.
3. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.
