AMENDMENT NUMBER 7**

This Amendment Number 7 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement Number 518-12 dated July 12, 2011 ("Main Agreement"), as amended by Amendment No. 1 through 6, and made between Community Systems, Inc. 10400 Eaton Place, Suite 501, Fairfax VA 22030 ("Contractor") and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the contract term under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows:

3. CONTRACT TERM

The Work shall commence on July 1, 2011, and be completed no later than June 30, 2018 ("Subsequent Contract Term"), subject to any modifications as provided for in the Contract Documents. Three (3) additional twelve (12) month options to renew referred to as a "Subsequent Contract Term" remain.


All other terms and conditions of the Main Agreement, as amended, shall remain in full force and effect.


