AGREEMENT NO. 19-142-R
AMENDMENT NUMBER 1

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 19-142-R dated January 23, 2019, ("Main Agreement") between Lakeshore Equipment Company dba Lakeshore Learning Material ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

2. CONTRACT TERM

The Contractor's provision of goods and services for the County ("Work") shall commence upon the execution of Amendment No. 1 by the County and shall be completed no later than June 14, 2020 ("First Subsequent Contract Term"), subject to any modifications as provided for in the Contract Documents regarding the Contract Term. No aspect of the Work shall be deemed complete until it is accepted by the County's Project Officer. This Agreement includes the ability to renew for three (3) twelve (12) month periods, from June 15, 2020 to June 14, 2023.

All other terms and conditions of the Main Agreement remain in effect.

In all other respects not specifically mentioned or altered by Amendment, the original Contract will remain in full force and effect.


