This is your notice that the above referenced contract has been amended. The "Contract Documents" consist of the scope of services, terms and conditions of Arlington County, Virginia Rider Agreement No. 17-189-R, dated March 22, 2017, and Loudoun County, Virginia RFQ No. 386, including any exhibits, attachments or amendments thereto.

The "Initial Contract Term" of the Main Agreement was effective until December 31, 2017. Amendment No. 1 corrects the "Initial Contract Term" of the Main Agreement in accordance with Loudoun County, Virginia RFQ No. 386. The Contractor's provision of goods and/or services for the County ("Work") shall be completed no later than December 31, 2019, subject to any modifications as provided for in the Contract documents. This Agreement includes three (3) additional one (1) year renewal options from January 1, 2020 until December 31, 2022 (each such period shall be referred to as a "Subsequent contract Term").

AMENDMENT NUMBER 1

This Amendment Number 1 ("Amendment") is made on the date of execution by the County and amends Arlington County Rider Agreement Number 17-189-R, dated March 22, 2017, ("Main Agreement") and made between INOVA Health Care Services, 8110 Gatehouse Road, 600 West, Falls Church, VA 22042 ("Contractor"), a Virginia Corporation authorized to transact business in the Commonwealth of Virginia, and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Contract Term of the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows:

1. Amend Paragraph 2 ("Contract Term") of the Main Agreement, Page 1 to read as follows:

2. CONTRACT TERM

The Contractor's provision of goods and/or services for the County ("Work") shall commence on the date of execution of this Agreement by the County and shall be completed no later than December 31, 2019 ("Initial Contract Term").

Upon satisfactory performance by the Contractor, and with the concurrence of the Contractor, if Loudoun County, Virginia renew theirs Agreement identified in Attachment B, the County may elect to renew this Agreement under the same contract unit prices for not more than three (3) additional one (1) year period(s) from January 1, 2020 until December 31, 2022 (each such period shall be referred to as a "Subsequent Contract Term"). However, if Loudoun County, Virginia does NOT renew their Agreement identified in Attachment B, this Agreement shall automatically expire on the date of Loudoun County, Virginia's contract expiration date.

All other terms and conditions of the Agreement, as amended, shall remain in full force and effect.
