### ARLINGTON COUNTY, VIRGINIA AGREEMENT NO. 514-12 AMENDMENT NUMBER 2

This Amendment Number 2 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement Number 514-12 dated June 30, 2011 ("Main Agreement"), as amended by Amendment No. 1 and made between Community Living Alternatives Corporation ("Contractor") and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the amounts to be paid under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows:

I. PARAGRAPH NO. 3 "CONTRACT TERM" AND PARAGRAPH NO. 4 "CONTRACT AMOUNT" SHALL BE DELETED IN THEIR ENTIRETY AND REPLACED WITH THE FOLLOWING:

#### 3. CONTRACT TERM

Work under this agreement shall continue from July 1, 2012, and be completed no later than June 30, 2013 ("First Subsequent Contract Term"), subject to any modifications as provided for in the Contract Documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may authorize continued operations of the Contractor under the same contract unit prices for not more than eight (8) additional twelve (12) month periods from July 1, 2013 to June 30, 2021 (Each such period shall be referred to as a "Subsequent Contract Term"). The Contract Amount and rates for each Subsequent Contract Term shall be in an amount mutually agreed upon but which will in no event exceed the funds appropriated for the service by the County Board of Arlington County. The total Contract Amount may be increased or decreased during the Initial and Subsequent Contract Terms if available funds exceed or, in the alternative, are not sufficient to maintain then current service levels.

#### 4. CONTRACT AMOUNT

The County will pay the Contractor in accordance with the terms of the Payment Terms paragraph and amended Exhibit B ("Contract rates for First Subsequent Contract Term") for the Contractor's completion of the Work described and required in the Contract Documents. The Contractor agrees that it shall complete the Work for the total amount specified in this section ("Contract Amount") unless such amount is modified as provided in this Agreement.

II. EXHIBIT B SHALL BE DELETED IN ITS ENTIRETY AND REPLACED WITH THE ATTACHED AMENDED EXHIBIT B.

All other terms and conditions of the Main Agreement, as amended, shall remain in full force and effect.

# CONTRACT RATES FOR THE FIRST SUBSEQUENT CONTRACT TERM (FISCAL YEAR 2013)

The County will pay the Contractor \$222.75 per day for each of the three (3) Arlington clients in the Supervised Apartment Setting, up to a maximum of 1,095 Bed Days, up to the maximum of \$243,912.00 per year. The County will also pay an additional \$3,390.00 per resident per year (\$282.50 per resident per month) for housing assistance, not to exceed a maximum of \$10,170.00 total. The total amount billed by the Contractor for the First Subsequent Contract Term shall not exceed \$254,082.00.

Clients shall not pay more than 30% of their income on housing and this shall be reflected in their residential fee agreement. The current residential fee agreement shall be received by Arlington County ID services in order for the Contractor to bill for rental assistance.

The County will reduce the monthly payment for discharged or attritioned County clients at the rate of \$222.75 per day per resident and \$282.50 per resident per month.

Arlington County funds shall be used in adherence to all Federal and Commonwealth of Virginia regulations governing residential programs that are licensed by DMHMRSAS.
