



**ARLINGTON COUNTY, VIRGINIA
AGREEMENT NO. 16-064-SS**

AMENDMENT NUMBER 1

This Amendment Number 1 (“Amendment”) is made on the date of execution by the County and amends Arlington County Agreement Number 16-064-SS, dated September 2, 2015 (“Main Agreement”), and made between Municipal Emergency Services, Inc., 4611 Assembly Drive, Suite G, Lanham, MD 20706 (“Contractor”), a Nevada corporation authorized to transact business in the Commonwealth of Virginia, and the County Board of Arlington County, Virginia (“County”).

Whereas the County and the Contractor desire to amend the Contract Term, Pricing and Notices under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows (revisions are underlined):

I. Revise Section 2 (“Contract Term”) of the Main Agreement, Page 1 as follows:

2. CONTRACT TERM

The Contractor’s provision of goods (“Work”) for the County will commence on October 1, 2015, and shall be completed no later than September 30, 2018 (“Subsequent Contract Term”), subject to any written modifications as provided for in the Contract Documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may, through issuance of a unilateral Notice of Renewal, authorize continued operations of the Contractor under the same contract unit prices for not more than two (2) additional twelve month periods from October 1, 2018 to September 30, 2020 (each such period shall be referred to as a “Subsequent Contract Term”).

II. Replace Exhibit A (“Pricing/Discount Structure”) of the Main Agreement as follows:

See the attached revised Exhibit A for the 2017 Scott Safety Price List and discount structure.

III. Revise Section 48 (“Notices”) of the Main Agreement, Page 12 as follows:

48. NOTICES
