AMENDMENT NUMBER 2

This Amendment Number 2 ("Amendment") is made on the date of execution by the County and amends Arlington County Agreement Number 17-191-ITB-1, dated March 13, 2017, ("Main Agreement as Amended") and made between American Blast Systems, Inc.
