(ii) Household trash means any and all accumulations of refuse material from the operation of a residential unit which is not garbage or recovered materials, including all bulky wastes, yard toys, and building material waste from residential do-it-yourself projects.

(iii) Yard trash means any and all accumulations of refuse consisting of grass, palm fronds, leaves, branches, shrubs, vines, cut trees, tree stumps, and other similar items generated by the maintenance of lawns, shrubs, gardens, and trees. The term excludes boards or lumber.

**TRIPLEX** means a residential building containing three single-family living units.

**B. CUSTOMER CLASSIFICATIONS.** Customers may be classified in this Contract as residential or commercial customers. Customers may also be classified in this Contract as toter-serviced customers or mechanical container-serviced customers. These two sets of customer classifications are not mutually exclusive.

## **SECTION 2 - TERM OF CONTRACT; OPTION TO RENEW**

The Initial Term of this Contract is ten years commencing on October 1, 2012 (the "Effective Date"), and ending on September 30, 2022, unless terminated prior to that date.

The Parties may renew this Contract by mutual consent for additional five-year Renewal Terms, subject to all existing contract provisions, or subject to such modifications as the Parties may agree to in writing. No such renewal will be effective unless an amendment setting forth all terms and conditions has been executed by both Parties and has been approved by the Daytona Beach City Commission.

## **SECTION 3 - SCOPE OF WORK; EXCLUSIVE RIGHTS**

**A. GENERAL DESCRIPTION; RESPONSIBILITY FOR COSTS.** Commencing on the Effective Date, and continuing throughout the Initial Term and any Renewal Terms, Contractor shall provide refuse collection, transportation, and disposal services, and recyclable materials collection and transportation services, as further described below, within the municipal boundaries. Contractor will provide such services to all of the City solid waste utility's residential customers, and all commercial

customers other than excluded commercial accounts referenced in **Exhibit C**, attached hereto and by reference incorporated herein. In addition, Contractor shall perform such services as are required to provide a complete recyclable materials program.

Contractor is responsible for all costs associated with the services required herein, including for provision of labor, vehicles and other equipment, machinery, supplies, insurance, bonds, permits, licenses, taxes, and interest, except where specifically provided otherwise herein.

**B. GENERAL REQUIREMENTS.** In providing the services herein, Contractor will comply with the following general requirements in addition to those described in the enumerated Sections below:

(1) Contractor will perform the services described herein in an efficient, sanitary, thorough manner.

(2) Contractor will not litter or cause any spillage (including waste streams, hydraulic fluid, oil, fuel, or otherwise) in providing the services. Upon being notified of littering or spillage, Contractor will provide immediate cleanup.

(3) Contractor will comply with all applicable federal, state, and local laws, and obtain and comply with all permits and licenses required by law.

(4) Consistent with Section 13 below, Contractor will provide a sufficient number and quality of vehicles and other equipment, and employ a sufficiently trained work force consisting of a sufficient number of workers, to enable Contractor to perform the services in compliance with all requirements.

(5) Contractor will operate Contractor's vehicles in a manner that maximizes safety and minimizes interference with vehicular and pedestrian traffic. Contractor will not suffer or permit vehicles in service to be unattended while on the streets. The City reserves the right to deny Contractor's vehicles access to certain roadways or alleys where, because of road conditions or other circumstances, denial of such access is in the public interest.

(6) In providing collection services, the Contractor will not be responsible for scattered refuse except where refuse has been scattered by Contractor's acts; in which case, Contractor will immediately pick up all such scattered



refuse.

(7) Contractor's employees will not be required to expose themselves to the danger of being bitten by vicious dogs or other animals in order to accomplish refuse collection in any case where the owner or tenants have such animals at large. In such event the Contractor shall immediately notify the customer and Public Works Director, in writing, of such conditions and of his inability to make collection because of such conditions.

(8) Contractor will submit to the Public Works Director a monthly report, no later than the 15TH of each month, for the previous month, regarding the following:

- Garbage and yard trash tonnage by route.
- Used tire tonnage for all routes.
- Commercial toter collection report listing, in alpha order, service address, size, days of collection and truck or route number.
- Commercial front load dumpster report listing, in alpha order, service address, dumpster size, days of collection and truck or route number.

The compactor reports are needed as directed by the City; by service address, size of container, date pulled, and number of pulls per month.

(9) In order that the City may be informed of the quality of service, the Contractor agrees to maintain an on-line, web-based electronic tracking system (hereinafter "Electronic Tracking System") for and with the City to record and retain records of all complaints and resolution of said complaints or inquiries of service for inspection by the City. The Contractor will provide the City and all residential and commercial customers with access to the Electronic Tracking System. The City may provide a link to the System from the City's web site.

**C. EXCLUSIVE RIGHTS.** While this Contract is in effect, in consideration of the scope of services to be provided by Contractor, and subject to compliance with all conditions of this Contract, Contractor will have the sole and exclusive right to collect refuse and recyclable materials within the municipal boundaries, subject to the following exceptions:

(1) Construction and demolition debris - Commercial and residential customers engaged in building or remodeling operations are permitted to remove or authorize haulers licensed under City ordinance to remove, construction and demolition debris accumulated as a result of their operations.

(2) Excluded waste and post-disaster debris may be collected and disposed of by the City or another contractor selected by the City.

(3) Recovered materials at commercial establishments - in accordance with Florida Statutes Section 403.7046(3), the City may not require commercial establishments generating source-separated recovered materials to use the City's solid waste service for collection and conveyance of such materials.

(4) Excluded commercial accounts - certain commercial establishments are exempted from being required to use the City's solid waste services. These establishments are listed in **Exhibit C**.

(5) Any exemptions specifically provided herein, such as the partial exemption provided to certain multifamily residential complexes for collection of yard waste.

(6) The City reserves the right to collect refuse in the course of its street maintenance and other City functions and pursuant to City ordinances.

(7) Any other exemptions required by federal, state, or local law.

## **SECTION 4 - REFUSE COLLECTION AND DISPOSAL**

**A. RESIDENTIAL COLLECTIONS.** Except for certain multifamily residential complexes as provided in Section 4.A.(4) below, all residential customers will receive toter-type container services as follows.

**(1) Scheduled Refuse Collection.** Contractor will provide scheduled refuse collections for all City residential customers in accordance with the following terms and conditions:

**(a) WHEN:** Twice per week, from Monday through Friday,
